• CU lost all 10 Pac-12 Conference matches in its first year. The Buffaloes did not win a conference match in 2011 their final year of the Big 12. CU has lost 25-straight conference matches since 2010.

• CU has lost 17-straight road conference matches since 2010 • CU lost all 10 doubles in conference play, and 21-straight doubles matches without winning the point (last Apr. 25, 2010, Texas) • CU's last conference road win was April 11, 2009 at Missouri, 4-3 (streak of 17 matches).

• Coach Kenneally has won 136 matches ranking second all-time in school history among women's tennis coaches and third all-time among both men's and women's tennis coaches.

• The CU tennis program was recognized by the NCAA on June 14 when the organization released its list of teams for the Academic Progress Rate (APR) Public Recognition Awards. The honor serves to highlight programs that have posted multi-year APR scores in the top 10 percent for their sport. CU received earned a perfect score of 1,000. This year's awards were given out to 954 programs nationally, recognizing teams for their APR performance from 2007-08 through 2010-11. It's the second straight year that the CU women's tennis team has earned the recognition; last year, men's golf was honored bringing the total to four programs in two years that have achieved the perfect APR score. The other instance Colorado was honored came during the program's infancy back in 2004-05, when the volleyball team garnered the award.
